Recommendation: "Establish an iconic landmark. We have looked at the planning documents and researched the Olmsted history of this area and would like to make the following recommendations:

- That parcels within the town center be purchased for open space as soon as possible. There are a number of potential locations for open space, but the parcels south of S. Winthrop Street, across from the transit station, offer the best connection between existing green spaces on Beacon Hill and in the Mount Baker neighborhood.
- That the City consider a land bridge to connect Cheasty Boulevard S. (via S. Winthrop Street) and Mount Baker Boulevard S. over the Martin Luther King Jr Way and Rainier Avenue S. intersection, replacing the existing pedestrian overpass. The land bridge could be used by pedestrians of all abilities and bicyclists and could serve as the iconic landmark that is recommended in the Urban Design Framwork.

By pursuing this plan, the City will realize a number of goals:

- 1) Connecting Cheasty Boulevard S. and Mount Baker Boulevard S. as intended in the 1903 Olmsted Brothers parks and boulevards system plan.
- 2) Improving access to open space for people of all ages in an underserved area
- 3) Ensuring that open space remains accessible, even as the city grows more densely populated
- 4) Improving pedestrian and bicyclists safety as they move across the wide, busy streets that run through the town center. Commuters moving between the transit center and the neighborhood, students traveling to and from Franklin High School, shoppers moving through the neighborhood, and walkers and bicyclists enjoying the area's large parks, green belts, and parks will all be able to move more easily through the town center and into surrounding neighborhoods.
